Dear President Akens:

The Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges, (ACCJC) at its meeting June 4-6, 2014, took action to review the Substantive Change Report submitted by the evaluation team and to approve the addition of new campuses to Carrington College California (CCC). Specifically, the campuses are Carrington Colleges in: Albuquerque, New Mexico; Boise, Idaho; Las Vegas, Nevada; Mesa, Arizona; Mesquite, Texas; Phoenix, Arizona; Portland, Oregon; Reno, Nevada; Spokane, Washington; and Tucson, Arizona. All of the new campus sites were visited by a team of evaluators, including the CCC Sacramento Home Office.

The Carrington College campuses provided evidence that they meet the ACCJC Eligibility Requirements, Accreditation Standards and Commission policies.

The Substantive Change Report will become part of the accreditation history of the College. The Commission requires that you give this letter appropriate dissemination to your College staff. This group should include campus leadership and the Board of Trustees.

The Commission also requires that the Substantive Change Report and this Commission action letter be made available to students and the public by placing a copy on the College website. *Please note that in response to public interest in disclosure, the Commission now requires institutions to post accreditation information on a page no farther than one click from the institution's home page.*

Institutions are expected to meet Eligibility Requirements, Accreditation Standards, and Commission policies at all times during the six-year review cycle. Carrington College California must demonstrate to the Commission at the time of the next regularly scheduled report that the newly consolidated Carrington College California is able to sustain meeting Eligibility Requirements, Accreditation Standards and Commission policies.
